#### Dear ABC of Texas Member,

As you know 2012 is not a legislative session year but there is still plenty to accomplish. At our next board meeting we will set our legislative priorities and begin working on them. We will start discussing bills that we might introduce and which senator or representative is best to carry them for us. We are also currently looking at all of the senate and house primaries and making recommendations on PAC contributions and endorsements. Additionally, our state president Jon Fisher is monitoring interim committee meetings and regulatory activities.

ABC of Texas is currently working with three other construction associations including Associated General Contractors-Texas Building Branch, Texas Construction Association and Texas Association of Builders, on issues dealing with the Franchise Tax (Margins Tax) or more specifically how the tax is being administered during audits. The state comptroller's office has agreed to work with our group to understand our franchise tax issues and attempt to resolve them. If we resolve our issues, we are likely going to be preparing legislation to make sure that the result does not change over time. The group mentioned above has retained Ryan Co., the best tax consulting firm in Texas, to manage this project. I would like to thank ABC National who has agreed to help fund this project through its Free Enterprise Alliance.

I am looking forward to favorable results from this year's elections. Remember, it's important to get involved with your local senators and representatives who have been supportive of our issues and help them win their races.

#### **Dear ABC of Texas Member,**

As you are probably aware and can also read about later in this issue, we finally have a date set for primary elections. As of the deadline for this issue, there was still some uncertainty if the DC panel acts soon and decides in a significantly different way than the San Antonio panel. That could cause the San Antonio panel to re-think its order and delay the

primaries even more. We should know that by the time you get this issue. Let's keep our fingers crossed!

I'm sure some of you are wondering why the primary run-offs are set for July 31, so far from the May 29 primaries. This is to comply with a new federal law requiring states to make better efforts to accommodate overseas balloting.

I also want to take this opportunity to thank ABC National's Free Enterprise Alliance for agreeing to fund one-half of our efforts in our Tax Advocacy Project which will run through the next legislative session. The ABC of Texas Board approved this project at its January meeting in response to challenges dealing with the Franchise Tax (Margins Tax) in both regulatory and legislative venues. Of course, there may be other tax issues addressed if they arise. Since these issues developed so late, the Board elected to assess chapters on a proportionate basis to fund this activity.

This Tax Advocacy Project is being pursued in cooperation with three other construction associations, allowing us to leverage our funds for maximum impact. FEA's grant cut the chapter allocations in half, hopefully minimizing the impact on local chapters' budgets in the process.

We owe special thanks to FEA trustees from Texas for supporting this project—State Board and TEXO Member GPaul Holliman, TEXO Member Phil Hoppman, and Greater Houston Chapter Member Rodney Page. I also want to thank our former ABC National Senior Manager, April Brown, for helping identifying this

source of funding. And, I would be remiss if I did not also thank Chris Singerling, Director of Political Affairs at ABC National, for his help with our request.

I also think it is important to acknowledge that this project is consistent with the Strategic Plan adopted by the Board in January following a planning meeting last year.

As you can tell, there is still a lot going on (elections, interim studies, preparation for the next Texas Legislature) even though the Texas Legislature is not currently in session.

As always, let me know if I can attend any local chapter functions to provide more information about what ABC of Texas is doing!

## NLRB Votes To Change Representation Election Proceedings

n November 30, 2011, the National Relations Labor Board ("NLRB") voted to revise the process for union representation elections, shortening the time from the filing of the election petition until the actual vote is held and thereby making it easier for unions to win elections and more difficult for employers to communicate with employees prior to the vote. These changes follow submissions to the NLRB of over 65,000 written comments on the proposed rule and public input gathered at a two-day hearing in July. The vote was on a "scaled back" final rule, not the proposed rule published in the Federal Register, which "will remain under consideration by the Board for possible future action."

In its vote, the NLRB Board resolved to prepare a final rule in the Federal Register that makes the following key changes to the current representation election procedures:

- Elimination of current procedures providing for pre-election appeals to the Board from the actions of the Regional Director on the election petition and providing instead only for a single, discretionary appeal of pre-election and postelection issues after the votes are cast. An appeal to the Board prior to the election is expressly limited to issues that would otherwise escape Board review entirely if not raised at that time.
- Elimination of current requirements that a vote cannot be held sooner than 25 days after the Board's Regional Director issues a Direction of Election. As a practical matter, this means that elections will be held sooner after the Direction

of Election than was previously the case, although the precise length of time may vary in each case.

• Clarification that a pre-election hearing is to determine only whether a question concerning representation exists and that the hearing officer has authority to limit evidence taken at the hearing that does not have relevance to a genuine issue of fact material to that issue. This means that many issues of individual voter eligibility as opposed to voting unit composition may be deferred to the post-election procedures rather than litigated prior to the vote. The right of parties to file a post-hearing brief to the Regional Director, previously guaranteed under the Board's rules, is now made discretionary with the hearing officer.

Some of the most onerous and unfair provisions of the original proposed rule, which produced a hail of criticism from the business community in the comments filed with the Board this past summer are tabled for now. These include:

- The requirement that a hearing be held within seven days of the filing of a union's representation petition.
- Allowing the union's petition to be filed electronically rather than the current practice requiring filing by hand or regular mail.

- The requirement that the employer prepare and file a comprehensive "statement of position" on the union's election petition no later than the date of the hearing, together with the requirement that any issues omitted by the employer from its statement are waived by the employer and may not be raised later.
- The requirement that unions be given employees' email addresses and telephone numbers prior to the election. Currently, the union receives a list of eligible voters from the employer prior to the election containing the employees' full name and residence address but not their email address and telephone number.
- The requirement that the voter eligibility list be given to the union within two work days of the Direction of Election instead of the current rule allowing seven work days.

The final rule amending the election case procedures is scheduled to take effect on April 30, 2012. Even though the final rule that is less onerous to employers than the original proposed rule, which would have reduced the time from filing of the election petition to the holding of the vote to as little as 10-21 days; the new rule, by eliminating pre-election appeals of Regional Director rulings, still substantially shortens the period from filing of the petition to the date of election from the current Board target of 42 days. Elections will be held quicker than before, the precise period being determined by the circumstances in each case.

#### An Update On the Board's Posting Requirement

On December 23, 2011, the NLRB Board announced that the effective date of its new notice posting rule has been postponed "at the request of the federal court in Washington, D.C. hearing a legal challenge regarding the rule." As a result, the new implementation date for the rule is April 30, 2012. The NLRB determined that "postponing the effective date of the rule would facilitate the resolution of the legal challenges that have been filed with respect to the rule."

On March 2, 2012, the court generally upheld the NLRB's posting requirement. The court found that the NLRB had the authority to promulgate the rule and that the rule was not arbitrary or capricious. The court did rule that the NLRB went too far when it declared that employers automatically commit an unfair labor practice by failing to post the notice. In rejecting a per se rule that an employer's failure to post is an unfair labor practice, the court found that the language of the National Labor Relations Act "prohibits employers from getting in the way—from doing something that impedes or hampers an employee's exercise of the rights guaranteed by [the Act]," not a "mere failure to facilitate the exercise of those rights." However, the court noted

that "nothing in [its] decision prevents the [NLRB] from finding that a failure to post constitutes an unfair labor practice in any individual case brought before it," but that any such finding must be based on the facts and circumstances of each specific case.


Although the court rejected the most controversial of the posting rule's requirements—that failure to post is an automatic unfair practice and stays the statute of limitations for any unfair practice charges—it leaves open the NLRB's ability to find both in individual cases. Accordingly, the rule could still have significant consequences for employers who fail to post the notice.

The D.C. Court's decision is likely to be appealed. Moreover, a separate lawsuit filed by the U.S. and South Carolina Chambers of Commerce, remains pending in the United States District Court for the District of South Carolina. As a result, it is imperative for employers to continue to monitor this issue.

# Redistricting and **Election Update**

n the last issue of Texas Merit Shop Journal, our lobbyist, Mike Toomey, penned an article on redistricting. He ended the article by summing up the status in one word—"uncertainty".

There was some concern on my part that this article would begin with that word. But, in a surprise announcement on Tuesday, February 28, the three-judge panel in San Antonio issued interim maps that more closely resemble those the Texas Legislature enacted.

The primaries are now scheduled for May 29. Candidate filing was reopened for Friday, March 2 to Friday, March 9. Candidates for state races must establish residency by April 9 and maintain it through the general election. The runoffs are July 31.

The maps still have to be pre-cleared by the US Department of Justice under the Voting Rights Act, but the department has said they will expedite the process so primaries can be held on May 29.

If the Justice Department (or the three-judge panel in DC if Attorney General Greg Abbott decides to go this route) denies preclearance, all bets are off.

Bottom line—it is more likely than not that the primaries will be held on May 29 using the interim maps. That should be more certain by the time you read this article. But, as it is written, there is still some uncertainty (that word had to come up again).

For example, if the DC court rules in a materially different manner than the San Antonio court on Section 5 issues (Voting Rights Act) regarding Congressional District 25 (ruling it a "protected" district), it could further delay the primaries. It is not just a question of what the DC court says, but when they will say it. This could potentially delay primaries into June or even make a June primary impossible. The San Antonio court could choose to hold the 2012 elections under the interim maps and order new maps for 2014—more uncertainty! Some of this uncertainty could be clear (or clearer) by the time you read this article.

So, what do the court-ordered interim maps do? The Congressional map arguably divides the four new seats, two and two. Some of the plaintiffs disagree, saying this map results in them ending up with 11 minority districts (those protected by the Voting Rights Act) that they would normally get. The Republican Party believes



they should get 25 out of the 36 seats in a normal election. Perhaps the biggest change from the first version of court-ordered maps is that this map re-establishes the legislatively-enacted new Congressional District 35 which stretches from Travis County down IH35 to Bexar County creating a new Latino opportunity district. Of course, there are significant changes in several other Congressional districts, specifically Congressional District 25 which changes to a majority Republican district.

The Texas House map, according to the Republican Party, gives Republicans 94 seats where the average Republican performance is 55% or better. That is four seats less than the legislativelyenacted plan. One of the more controversial areas is Nueces County where the court ordered districts identical to those enacted by the legislature causing the Mexican-American Legal Defense and Education Fund (MALDEF), one of the plaintiffs, to complain that the San Antonio court should have at least used the previously-unacceptable State "compromise" plan that reflected what the State was willing at one time to offer to increase political opportunity for Latinos.

The Texas Senate map restores Senate District 10 to its preredistricting make-up, giving the incumbent, Senator Wendy Davis, basically the same electorate that elected her in the Obama wave in 2008. It restores Senate District 30 (Senator Craig Estes) to the same district the legislature enacted.





One on One With...

#### STATE REPRESENTATIVE TODD HUNTER

Todd A. Hunter is serving his sixth term in the Texas House of Representatives. He was first elected to public office in 1988 and retired from public service in 1997 so that he could help raise his three young children with his wife Alexis. In 2008, Todd was elected as a Republican representing District 32 composed of Aransas, Calhoun, San Patricio and part of Nueces County. He is currently the senior partner of Hunter and Handel, P.C. in Corpus Christi.

During Hunter's previous service in the Texas House of Representatives, he chaired the House Committee on Civil Practices where he was active on tort reform. He also served on various other committees including Ways and Means, Appropriations, and State Affairs. Upon returning to the Texas House in 2009, Texas House Speaker Joe Straus named Todd as Chairman of the House Committee on Judiciary and Civil Jurisprudence. In 2011, immediately following a speech to ABC of Texas members at a Legislative Day breakfast, Hunter was named by Speaker Straus to chair the very important House Committee on Calendars which determines which bills go to the full House and when they are debated. In 2011, he also chaired the House Select Committee on Election Contests and served on the important House Redistricting Committee.

Born in Bartlesville, Oklahoma in 1953, Todd earned his Bachelor's degree from the University of Kansas in 1975 and his J.D. from Southern Methodist University in 1978. He has lived in the Corpus Christi area for over 30 years where he met and married his wife, the former Alexis Taylor. They have three children: Todd Jr., a graduate of Texas A&M University -College Station who is attending law school at St. Mary's University in San Antonio; Michael, a graduate of Trinity University in San Antonio who is attending graduate school at Texas A&M University- Corpus Christi; and Christina, who is attending the University of Texas-Austin.

Hunter has been active in numerous community and civic affairs as a sponsor for youth league baseball teams and a director and advisory board member for the Coastal Bend Boy Scouts of America. He has also served as a board member of numerous other civic groups, including the Consumer Credit Counseling Service and Texas Lyceum Association. Todd is a member of the Corpus Christi Rotary Club, of the Church of the Good Shepherd Episcopal Church in Corpus Christi, and of numerous business and civic organizations throughout District 32.

Q: Last session, you chaired what most consider to be the most powerful committee in the Texas House - the House Committee on Calendars. What can you share with us about that experience?

A: It was an honor to be named by the Speaker of the House as the Chairman of the House Committee on Calendars. The Calendars Committee is basically the gatekeeper committee for scheduling agenda items for the Texas House of Representatives. With the Speaker's input and support, we tried to make this a very open process that would work very efficiently and effectively. I am honored to serve as Chairman of the House Committee on Calendars. I believe that I am only the second South Texan in the history of Texas to have served in this capacity.

#### Q: What do you see as the biggest challenges facing the state going into the next Texas Legislature in 2013?

A: In 2013, budget and revenue issues will be large challenges. It is important that the business community be involved in the development of these policies. The friendlier and stronger the business climate in Texas, the more jobs will be created and the more economic success will be achieved. In addition to the budget, water issues will also be a large challenge. Not only have we had drought issues, we have contractual issues that affect water rights throughout the state. Water will be an important issue to review statewide. Higher education needs to be promoted and supported because it provides a strong educational foundation for the State of Texas and it is an economic generator as well. Higher education will be an issue that needs to be assisted in 2013.

#### Q: What are your personal priorities next session?

A: I personally want to make sure that we assist the Speaker of the House in making a smooth legislative session occur. I am interested in helping Texas develop more jobs in the construction industry as well as promoting business opportunities for all areas of our great state. I also want to make sure that the State of Texas passes laws that are effective in handling, coping and resolving human trafficking issues in the State of Texas.

# Q: You've been an ABC member for quite a while. What do you see as our strengths and weaknesses in the state political scene?

A: ABC is a tremendous organization. ABC has worked with my office for many years. ABC does a great job educating its members as well as legislators. I see no weakness but only strengths to build upon. ABC does a great job in communicating, as well as personally visiting with lawmakers. I encourage ABC and its members to continue doing its fine job. Please call on me at any time.

# Q: What do you see as the greatest challenges facing the construction industry in the next Texas Legislature?

A: The greatest challenges will revolve around budget and revenue matters. In addition, there will be challenges that effect the construction industry relating to contract issues which seem to develop in each legislative session. Also, we need to make sure that the construction industry is involved early in the policymaking so we make sure that common sense legislation is passed.

# Q: What do you see as the greatest challenges facing merit shop and free enterprise advocates in the next Texas Legislature?

A: The greatest challenges facing merit shop and free enterprise advocates are simply communication and activity. It is important with a new legislative session that merit shop and free enterprise advocates educate and have constant contact with lawmakers. The greatest challenge will be to make sure that new lawmakers understand the issues that have developed over the last several years. Overall, ABC has done a great job and needs to continue its great performance in 2013.

#### **ABC SOUTH TEXAS CHAPTER**

The South Texas Chapter started off the year with the annual ABC PAC phone blitz. ABC is working with BXTX to expand the number of classes and to include sophomores. The concept would be for the sophomores and juniors to complete the PACE program, which includes completion of the OSHA 10 Hour course, and then when they become seniors in high school they would be taken through the Contrens Learning Systems's Core Curriculum. This would allow those students who plan to enter the workforce the opportunity to move to the chapter's apprenticeship program in the trade of their choice. As a result of the articulation agreement with St. Philips College, when the students complete the apprenticeship program they can obtain up to 32 college credit hours towards an Associates Degree in Applied Science.

South Texas Chapter member Middleman Construction recently received LEED Platinum, currently the only LEED Platinum project in San Antonio, for the Eagle Veterinary Hospital. The project also received an ABC National EIC Eagle award. Congratulations Middleman Construction!

The first membership mixer for 2012 was held the last week in January at the Oak Hills Country Club. The annual "Contractor In A Box" mixer drew over 275 members and guests. This year's program was expanded to include members of the architectural and engineering community. The mixer is designed to provide a forum to develop additional business relationships.
