This year's March primary saw vast amounts of cash dumped into races from socially conservative Republican groups, (Empower Texans, New Leadership PAC, and Texas Right to Life contributed over \$5 million this cycle), as well as establishment Republican groups (Texas House Leadership Fund PAC, Associated Republicans of Texas PAC, and Texas Association of Realtors PAC contributed over \$3 million this cycle). There are also several seats headed to runoffs pitting socially conservative Republican candidates against establishment Republican candidates.

Primary runoffs are scheduled for May 22nd, 2018. The results of the runoffs will give the winning Republican side momentum heading into the race to replace retiring Speaker Joe Straus (R – San Antonio) as leader of the Texas House.

2018 Primary Election Results

TEXO CHAPTER (DFW)

SD-8: In one of the most expensive primaries (combined nearly \$10 million was spent), sitting Texas Attorney General Ken Paxton's wife, Angela Paxton (McKinney), won a tough primary over largely self-funded businessman, Phillip Huffines (Plano), brother of Sen. Don Huffines (R-Dallas).

SD-30: Incumbent Sen. Craig Estes (R–Wichita Falls), an establishment Republican, lost to Lt. Gov. Dan Patrick and Empower Texans endorsed candidate—sitting State Rep. Pat Fallon (R–Prosper) who largely self-funded his campaign.

SD-2: In a Senate race that at times turned personal, Lt. Gov. Dan Patrick and Empower Texans backed incumbent Sen. Bob Hall (R-Edgewood) warded off a challenge by sitting State Rep. Cindy Burkett (R-Sunnyvale).

HD-99: Incumbent Rep. Charlie Geren (R–Fort Worth) easily defeated Empower Texans backed challenger Bo French (Fort Worth) in one of the grittiest campaigns this primary cycle.

HD-114: Incumbent Rep. Jason Villalba (R-Dallas) was ousted by Empower Texans backed Lisa Luby Ryan (Dallas), with Ryan getting 53% of the vote.

HD-106: OPEN SEAT—Empower Texans and U.S. Sen. Ted Cruz endorsed Jared Patterson (Frisco) who defeated Associated Republicans of Texas backed Clint Bedsole (Frisco) in what is now Sen. Fallon's old district.

RUNOFF IN TEXO CHAPTER:

HD-107 GOP: Former US Navy fighter pilot Joe Ruzicka (Dallas) will face Empower Texans backed candidate Deanna Maria Metzger (Mesquite). The winner of that runoff will face incumbent Rep. Victoria Neave (D-Dallas) this fall. It will be interesting to see what happens. HD-107 is one of Texas' few swing districts with an Optimal Republican Voting Strength (ORVS) score of 50.9%, which makes it dead even.

GREATER HOUSTON CHAPTER (Houston)

SD-6: State Sen. Sylvia Garcia (D-Houston) is headed for D.C. having won the democratic primary for the heavily Democratic district, CD-29. Current State Rep. Ana Hernandez (D-Houston) and current State Rep. Carol Alvarado (D-Houston) have announced their runs for the soon to be vacant seat in a special election likely to happen later this year.

HD-18 Incumbent and establishment candidate Rep. Ernest Bailes (R–Shepherd) defeated Empower Texans backed Emily Kebodeaux Cook (Liberty). HD-23: Incumbent Rep. Wayne Faircloth (R–Galveston) lost to Empower Texans and Governor Abbott endorsed candidate Mayes Middleton (Wallisville).

HD-134: Rep. Sarah Davis (R–West University Place) defeated Empower Texans and Governor Abbott endorsed challenger Susanna Dokupil (Houston). In a district with an ORVS of 53.3%, Davis faces a democratic challenger in the fall from Allison Sawyer (Houston), the owner of an oil and gas safety company.

HD-126: OPEN SEAT— Sam Harless (Spring), husband of former state Rep. Patricia Harless, avoided a run off, beating challenges from attorney Kevin Fulton (Houston) and Gail Stanart (Houston)—wife of current Harris County Clerk Stan Stanart.

CENTRAL TEXAS CHAPTER (Austin)

HD-47: Incumbent Rep. Paul Workman (R-Austin), a big ABC supporter, secured a majority of votes despite a challenge from veteran and Empower Texans endorsed candidate Jay Wiley (Austin).

RUNOFF IN CENTRAL TEXAS CHAPTER:

HD-54 GOP: Incumbent Rep. Scott Cosper (R-Killeen), another big ABC supporter, will face veterinarian Brad Buckley (Killeen) in May.

SOUTH TEXAS CHAPTER (San Antonio)

HD-122: Rep. Lyle Larson (R-San Antonio), facing criticism from Governor Abbott, fended off Empower Texans backed candidate Chris Fails (Hollywood Park) with 59% of the vote.

RUNOFF IN SOUTH TEXAS CHAPTER:

HD-121 GOP: Establishment candidate and Speaker Straus supported Steve Allison (San Antonio) will face Empower Texans endorsed candidate Matt Beebe (San Antonio) to replace the seat vacated by retiring Speaker Joe Straus.

MID COAST CHAPTER (Victoria) & COASTAL BEND CHAPTER (Corpus Christi)

CONGRESSIONAL RUNOFF IN ABC-TEXAS MID-COAST CHAPTER & ABC-TEXAS COASTAL BEND CHAPTER:

CD-27: OPEN SEAT: Former Texas Water Development Board Chairman, Bech Bruun (Corpus Christi) will face State Republican Executive Committee member, Michael Cloud (Victoria) in May.

Hurricane Updates

GREATER HOUSTON CHAPTER

On August 25, 2017, Hurricane Harvey hit Houston and surrounding areas with a force so powerful, millions of people were forced to evacuate. We watched as Houstonians gathered to help rescue, relieve, and restore fellow citizens impacted by this disaster. We were heartbroken when we saw the people who lost their lives, homes, and businesses due to the high flood waters in our city. But as roads began to clear, there were still so many victims who needed help, and will need assistance for months to come. Many of our fellow citizens along the Texas Gulf Coast felt the devastating effects of Hurricane Harvey, and we are prepared to help our neighbors, friends, co-workers, and fellow Houstonians.

While the ABC and CMEF offices did not suffer any damage, we saw the impact the storm had on our city, and launched a "Members Helping Members" Campaign. We created an interactive tool to help identify members in need and matched them with other members who could provide support or assistance. Updated multiple times daily, the map allowed members to list their specific needs for materials, supplies or volunteer labor.

As we continue to help each other overcome the disaster of Harvey, we will rebuild our city better and stronger. We are committed to helping our city by being a resource to our members who need help now and in the months ahead. Together, we are Houston Strong.

TEXAS GULF COAST CHAPTER

A week after Hurricane Harvey made landfall, roughly twohundred square miles of Brazoria County became inundated with water from the Brazos River impacting over eight thousand homes. At ABC Texas Gulf Coast Chapter, every employee was impacted in some way. Some were flooded, some housed friends and family who were displaced, and some worked tirelessly to help others.

Ron Speir, of ABC Texas Gulf Coast, who actively participated in rescues said, "It was amazing to see how many responded to the needs of the residents in Brazoria County. Along with first responders we had neighbors, co-workers, employers, church groups, and total strangers from around the state and country.





They all came to the aid of those in need. No one asked or cared if you were rich or poor, liberal or conservative, or what faith you believed in...they just arrived, ready and willing to help others. They came with boats, trucks, tools and truly made a difference in the lives of those devastated by the storm."

In the Freeport area, local industry supported recovery efforts by forming employee work crews, cleaning kits and even supplying travel trailers to be used as temporary lodging for those in need.

As we became bombarded by non-stop media coverage, we saw countless water rescues of families, pets, and livestock. It was a surreal experience. But in the midst of vast destruction, many people opened their homes to provide meals and shelter for those displaced and for the crews who came to help. Teams formed, organized by employers and churches, began to help people cleanout their homes and start the rebuilding process.

While it was incredible to see the outpouring of support for those most affected by the storm, let us not forget them now as they continue to transition through the very long processes of rescue, recovery, and rebuild. Even with all the acts of kindness, generosity and support, there are still hundreds of families displaced and living through the process of rebuilding their lives.

It is our hope that you will continue to keep those affected in your thoughts and prayers, and continue to provide support.

SOUTHEAST TEXAS CHAPTER

In the days and weeks after Hurricane Harvey's late August landfall, the resilience of Texans, as well as the Gulf Coast construction industry, were put to the ultimate test. The largest storm to hit the United States since 2005, Harvey slammed into Rockport, as a Category 4 hurricane, and then dumped more than forty inches of rain as it slowly moved across Southeast Texas. It would prove to be the strongest and one of the costliest storms in our history, displacing more than thirty thousand people and prompting Governor Greg Abbott to create the Governor's Commission Rebuild Texas program in order to address the billions of dollars in damages. ABC offices from Corpus Christi to Nederland were impacted at varying degrees, as well as hundreds of member companies. Fortunately, the ABC Southeast Texas office was spared from the storm. In true ABC fashion, many members volunteered to help with evacuations, food, clothing, and shelter, and aided customers with repairs and restorations, even in the midst of dealing with their own personal losses.

TEXAS COASTAL BEND CHAPTER

A large portion of the Coastal Bend area was affected by Hurricane Harvey in late August. Fortunately, Corpus Christi was spared, but the areas from north Aransas Pass through Rockport and Woodsboro and up to Houston, suffered heavy damage. Members have been very busy trying to get all the areas back together. It's an ongoing effort but the dedication to get everything done is incredible.

Repcon, Inc. held a supply drive immediately following the hurricane where they collected much needed water, clothing, cleaning supplies, and food. Ram Tool went out to Port Aransas the first weekend after the hurricane and served nearly four hundred bowls of fresh, hot jambalaya which was very much appreciated by all those working to recover any salvageable items from their properties and the volunteers that worked tirelessly to assist with cleaning up.

Dawson Recycling continues to work seven days a week in an effort to remove the piles of debris from the area homes and businesses. So many members put teams together to go out and work for individuals who needed help with tree removal, minor home repairs, and deliver important supplies.

A recent drive through the Aransas Pass, Rockport, and Woodsboro areas was heartbreaking as there is still so much damage left. Each of the affected areas are slowly coming back together as the communities continue their effort to reorganize and put the pieces back together. There are many businesses open and ready to serve the visitors as the peak season for tourism is upon us.

TEXO CHAPTER

TEXO collected \$16,625 in donations at the TEXO YCC Tailgate for hurricane efforts as well as over 1,200 cans of food at the November Young Constructor's Council meeting.

SOUTH TEXAS CHAPTER

This past October, the South Texas Chapter was scheduled to host its annual fishing tournament in Rockport, however, Harvey changed those plans. Instead of a fishing tournament, the chapter conducted a Volunteer Work Day. Around two dozen volunteers spent Friday, October 13 assisting with the clean-up. The crew from Central Electric provided lunch for the ABC volunteers, volunteers from Samarian's Purse and the homeowner. The reconstruction of the Coastal Bend area is going to be a long-term process.



STATE REPRESENTATIVE Dade Phelan

Representative Dade Phelan was born and raised in Beaumont, Texas. He is a commercial real estate developer and licensed broker in Southeast Texas. His fourth generation firm owns and manages retail, industrial and office property in Texas and Arkansas. He received his bachelor's degree in Government and Business from The University of Texas at Austin.

Phelan serves as Vice-Chair of the Natural Resources Committee as well as on the Calendars Committee, Appropriations Committee, Appropriations Sub-Committee on Articles VI, VII & VIII and on the Select Committee on Ports, Innovation and Infrastructure. Capitol Inside Magazine named Representative Phelan one of the most outstanding freshmen after his first session and in 2017 honored him again as the Most Valuable Sophomore member of the Legislature. In 2018 Phelan was honored by the Boys and Girls Club of Texas as their Legislative Champion, Legislator of the Year for the Texas Apartment Association and a Most Valuable Legislator for the Texas Association of Community Schools.

Representative Phelan is one of three house members appointed to the State Water Infrastructure Fund for Texas Advisory Committee. The purpose of the panel is to review the overall operation, function and structure of the state water fund and to assist the Texas Water Development Board in achieving its goal of providing \$27 billion in state water plan projects over the next 50 years.

American Council of Young Political Leaders selected Representative Phelan as one of seven United States foreign delegates. In August 2016 he traveled to Asia for a diplomatic exchange with China and Taiwan's next generation of political leaders.

Mr. Phelan is two time Governor appointee to and former president of the Lower Neches Valley Authority. He recently served as a board member to Southeast Texas CASA, Golden Triangle Coastal Conservation Association, The Jefferson Theater, St. Anne Catholic Church and as board secretary of Catholic Charities of Southeast Texas. His wife, Kim, is a solo practitioner attorney and together they have four boys, Ford, Mack, Hank and Luke.

Please describe your professional background.

I am a commercial broker and partner at Phelan Investments, a fourth generation real estate development firm. We build, own and manage retail, industrial and office property in Texas and Arkansas. In a previous life I was a legislative staff member to State Representative Mark Stiles, U.S. House Majority Leader Dick Armey and State Senator Tommy Williams. I received my bachelor's degree in Government and Business from The University of Texas at Austin.

How do you believe the Legislature did last session in addressing our state's needs?

Despite severe budget constraints, the 85th Legislature addressed the needs of an ever-growing Texas while also being fiscally responsible. Just to name a handful of accomplishments - we passed significant mental health and Child Protective Services reforms, avoided draconian cuts to higher education,

continued border security funding and again provided additional resources to assist our retired teachers. The overall budget total was held below population growth and inflation for the second straight session.

What were your personal priorities last session and how did they fare?

My first priority was ensuring Senate Bill 1 did not eliminate the numerous higher education victories of the 84th Session. I represent four higher education institutions in Southeast Texas - Lamar University, Lamar State College-Orange, Lamar State College-Port Arthur and Lamar Institute of Technology. I consider them the lifeblood of our community. They are preparing the next generation of professionals and skilled laborers for the Texas workforce - engineers, draftsmen, welders, HVAC technicians, process operators, health care, maritime personnel, etc. In 2015, we not only funded numerous vocational training programs but also passed a comprehensive tuition revenue bill to provide the necessary infrastructure improvements. The cuts proposed by several versions of the Appropriations Act would have eliminated many of these curriculums. In my district alone several state-of-the-art buildings, built by ABC members, would be sitting empty. Due to tremendous efforts by many, the final version of Senate Bill 1 did not contain the severe reductions. With vocational trades being essential to our economy and the construction industry, the Legislature must continue to invest in higher education.

You have a very good relationship with members of the Southeast Texas Chapter of ABC. What is your opinion of the role the construction industry plays in our state's economy?

The construction industry, especially in Southeast Texas, is absolutely vital to both the state and U.S. economy. The University of Texas, has a slogan "What starts here changes the world" but I like to say "What starts in Southeast Texas fuels the world." Our industrial/petrochemical complex and seaports are not just national leaders but global leaders. With over \$30 billion in the local pipeline, they are preparing for massive expansion. None of this economic growth would be possible without our local construction firms. Southeast Texas Chapter of ABC members can work on the largest refinery in North America one day and build a neighborhood elementary the next - all with local talent.

What do you see as the biggest challenges facing Texas that you will have to address next session?

Writing a budget for the worlds 10th largest economy is always a challenge but the upcoming biennium's House Bill 1 might be the most difficult in the last decade. We have considerable health care and public education funding shortfalls that would be problematic enough without the added widespread devastation from Hurricane Harvey. Voters have been very clear in expecting property tax reductions and school finance reform as well. Meanwhile thousands of new Texans arrive here every day and they do not bring asphalt, teachers, water, nurses, bridges, state troopers, etc. with them. If Texas wants to continue to be the "State of Opportunity", we must support its growth. It all adds up for an interesting debate beginning January 8th, 2019.



CENTRAL TEXAS CHAPTER

2018 is off to a great start at the Central Texas chapter! The chapter started the year with a new member breakfast and orientation. Over fifteen new members attended the session to learn about ABC and the many paths to engagement within the various committees and initiatives.

On February 20, ABC Central Texas partnered with the Austin chapter of Construction Financial Management Association (CFMA) to host ABC's Chief Economist Anirban Basu at the University of Texas Club for his lively Economic Forecast presentation and breakfast. Over one-hundred members were in attendance.

On February 21, ABC Central Texas partnered with AGC Austin to host a fundraiser for State Representatives Paul Workman and John Cyrier at the Headliners Club.

The chapter also launched its Emerging Leaders Program, something that's been in the works for the past several months. Co-chaired by Trevor Lundgren from DPR and Damani Alexcee from Heartland Acoustics, this active group of future leaders will engage with the chapter and provide networking, professional, and personal development opportunities to its members. They recently hosted a networking event and will be meeting on a regular basis to set strategic goals.

Over the past five years the Foundation has awarded approximately \$286,000 in scholarships to qualified young men and women who are interested in pursuing a career in the construction industry.

GREATER HOUSTON CHAPTER

In March, chapter staff attend the ABC National Convention and Craft Championships in Long Beach, California. Two contestants were sponsored to compete in the millwright and electrician categories. While both did very well, millwright competitor

TEXAS MID COAST CHAPTER

The ABC Texas Mid Coast Chapter is developing the Mid Coast Construction Academy (MCA) for electrical and plumbing craft training with expectations to be opening fall 2018.

The mission is to promote and educate students and unemployed individuals about the construction industry and develop skilled labor through pre-apprenticeships and apprenticeships. The attained skills will promote local and regional job growth that pay wages that are at least equal to the prevailing wage for the applicable occupation in the local labor market area.

The Pre-Apprenticeship program is for 11th and 12th grade high school students. Currently, the chapter is partnering with nine local independent school districts who will provide transportation for their students to attend the pre-apprenticeship classes at the Academy in Victoria. From the nine school districts that have



partnered with the Mid Coast Construction Academy (Calhoun, Cuero, Ganado, Goliad, Industrial, Refugio, Yoakum, Yorktown, and Victoria), fifty-four high school students will be enrolled as soon as the application process has been completed.

These students will concurrently earn Career & Technology Education (CTE) credits with their local high school as well as NCCER Training Credentials and Certifications. Upon high school graduation, they will have direct entry into the adult apprenticeship program upon completion of the application process. The chapter is also exploring possibilities of partnership with a local community college to offer dual credit CE hours while students are enrolled in the program.

Additionally, the Apprenticeship program at the Mid Coast Construction Academy will offer Department of Labor-approved electrical and plumbing apprenticeship programs. Local employers, many of which are chapter members, will partner with the MCA to provide on-the-job training for students while they work to earn a certificate of completion from the Bureau of Apprenticeship & Training, as well as from NCCER. Upon completion of the program, apprenticeship students will be eligible to sit for the journeyman level exam for their prospective craft.

With the MCA launching the first regional program of its kind, the surrounding communities and school districts have shown lots of support and interest. In fact, one of the partner ISDs, Cuero Independent School District, accompanied ABC staff with five prospective students to the Skills USA competition hosted by the Craft Training Center in Corpus Christi on April 6 to get an idea of what a similar program looks like.

The MCA is excited to boast small classes with hands-on training, NCCER accredited courses and certified instructors with journeyman level experience, and job placement assistance.

TEXO CHAPTER

2018 began with a series of strategic planning sessions for TEXO and its members. The Board of Directors met for their yearly planning meeting with major outcomes that included new governmental affairs fundraising ideas, a shifted direction and focus for the Build Texas Proud campaign, the future of professional development offerings, and general improvements to TEXO processes and procedures.

This quarter highlighted the introduction of a new monthly networking series, Colleagues + Cocktails. With an emphasis on networking to build relationships and foster business within the construction industry, the event series travels to various locations in the Dallas and Fort Worth areas. Each month has proved to be successful with increasing interest and popularity among members and non-members.

The 2018 TEXO Foundation Student Competition took place on February 19. The competition featured 12 schools from the ASC Region 5 with twenty-five teams competing in Heavy Civil, Commercial, and Design-Build/International Design-Build. Students competed using member companies' construction projects to show their skill and interest in careers in construction. In addition to the competition, the event featured a networking lounge where members had the opportunity to meet the interested students and receive resumes from potential future employees.

A solid foundation has been laid for many new initiatives as well as continuing and completing current ones. With the launch of the 2018 Challenge Cup Competition, more opportunities will be available to members for networking, team building and unifying the construction industry. The TEXO staff and its members look forward to the continuing evolution of the company and its services.
