LETTER from the Chairman



Jon Fisher's letter in this issue of the Texas Merit Shop Journal gives the reader a very good synopsis of important state issues affecting ABC members. I urge everyone to read it.

I am writing on the single issue one should focus on in determining for whom to vote in the upcoming presidential election. What issue is so paramount that it is more important than all others; metaphorically, an issue that is worth dying for, or stated another way, worth fighting to the death for? Is the election of this president, metaphorically, a Battle Royale? "Battle Royale" - Wikipedia says the term refers to a novel by Japanese writer Koushun Takami. The story tells of junior high school students who are forced to fight each other to the death.

The major parties are treating the presidential election this year very much as a Battle Royale. Whether one is entertained by, approves or

disapproves of the prior, current, or future middle-school conduct of the major party's candidates, both major parties and their candidates should be fighting to the death. That said, "fighting to the death" should not be merely for "important" reasons. Pundits want to discuss and frame the argument on what they believe is important, i.e. whom said what to whom, or about whom, who did or didn't lie, cheat, steal, or verbally abuse. Pundits tend to focus on issues which are raised by conduct of others in the previous 24-hour news cycle; the "flavor of the day"; the economy, terrorism, immigration, domestic policy, and all flavors and shades thereof. But, important issues are those which if one loses, one wants to live to fight another day.

But, what issue is more than important; that is, an issue so paramount, that it warrants a fight to the death – that is metaphorically giving one's life to win something. In our country, freedom, liberty, and the pursuit of happiness have been reasons for, in fact, fighting to the death, giving one's life for a paramount reason. One could argue that all of the above "important" reasons have some effect on freedom, liberty, and the pursuit of happiness.

If one probes further, however, all of these "important" reasons have one thing in common, each is significantly governed by those making, amending, and implementing laws. The making and implementation of laws is important, but it is equally self-evident from the prior conduct of politicians affiliated with both parties, that it is much too easy to simply issue regulations contravening the written law, selectively enforce the law, or issue the infamous "executive order" to circumvent laws.

The paramount issue is "who interprets both the making of laws and the conduct of those implementing the laws?" The answer for those in the United States is the judges of our courts. Why this election is, and should be, metaphorically, a Battle Royale, is the very simple concept of who will nominate those to sit on the US Supreme Court. The answer to this question is paramount because a Supreme Court Justices opinion affects you and the country long term, likely longer than the life time of many who are reading this.

There will likely be three or four new Justices voted and approved by the Senate to the Supreme Court in the very near future. The appointment is for life, or until resignation. Supreme Court justices are individuals, with life experience from which each justice draws to interpret the written word as well as the conduct of those implementing the law. Each justice absolutely has a "bent". So, regardless of all the "noise" related to both major party's candidates, their conduct, various policies, and peccadillo's, the governing and paramount issue above all others: Which individual presidential candidate do you want nominating future Supreme Court justices?

LETTER from the President

This is the last issue of Texas Merit Shop Journal before the November elections. I urge everyone to vote and get active in local elections.

Mike Toomey, our lobbyist, and I have identified races in chapter areas that are important to the State of Texas and ABC. If you are interested in getting involved, check with your Chapter President to see if we have identified races in your area. I remember a legislator telling me once that he could not remember the names of everyone that gave him \$1000 or more, but he did know the names of everyone that volunteered in his campaign!

By now, all of you should have received instructions from your chapter on how to access the webinar on Lien Law Modernization which was held on July 25. We had 24 members participate. Our panelists—Ben Westcott

and Fred Wilshusen—did an excellent job of explaining the proposal and answering questions. The most important thing for members to do is to try to understand the proposal and provide us feedback—directly to Ben or me. As I said in my introductory remarks in the webinar, this proposal is not designed to produce more liens; it is designed to provide a better system for assuring all are paid thereby eliminating the need for liens. This is attempted by creating a system for owners and general contractors to be aware of who needs to be paid. This gives owners and general contractors the ability to have a list of who needs to provide lien waivers so "surprise liens" are avoided. And it provides a simpler way with fewer "tripwires" for subcontractors and suppliers to preserve lien rights by providing an upfront notice (the same notice that lets owners and GCs know who needs to provide lien waivers). Please do not hesitate providing feedback. We need to know if you like

the proposal or not. We do anticipate getting feedback from some other stakeholders by the time this issue reaches you so we need to know what you think also.

One of our other highest priorities for the next legislative session is Neutrality in State Government Contracting. The One-on-One in this issue features the author of that bill-State Rep. Tan Parker, a longtime friend of ABC.

Other articles in this issue include a rundown on the November elections and more on the Lien Law Modernization Proposal.

The next issue of Texas Merit Shop Journal will be January 2017. We will have write-ups on our Priority Issues.



Texas General Election **Prospectus**

Many pollsters predict that a particularly galvanizing 2016 presidential election will drive non-voters to the polls in droves this November. That prediction brings uncertainty to candidates further down the ballot. Why? A Trump or Hillary ballot comes with the possibility of first time voters showing up and casting straight-ticket ballots, regardless of how that voter might actually align with candidates further down the ballot. On the other hand, historically straight-ticket voters might opt to vote down the ballot given their "lesser of two evils" candidate at the top. Lastly, Hillary's historic run could increase female voters looking to vote for female candidates. It's clear that the presidential race will have a significant impact on closely contested races this November.

Even so, the ground is not shifting under Texas politician's feet. No state-wide office holders are up for election this year. In the House, almost two-thirds (82 to be exact) of the candidates will not face an opponent in the fall. Of the remaining 68 House races headed to a general election, 62 will host an incumbent. In the Senate, of the 16 seats up for grabs this election cycle (senators run for 4-year terms), only 4 will face an opponent in the general election. Of those 4, only one will not feature an incumbent.

Using what is known as the Optimal Republican Voting Strength (ORVS) metric, we can identify the few competitive general election races. The ORVS is a rough assessment of Republican support in a particular district for a Republican candidate. Although it is not a definitive tool, a Republican candidate in a district with an ORVS of 57% or greater is very likely to carry that district. A district between 50%-56% is hotly contested. It is also important to note that a general election race featuring a Libertarian candidate can take around 3% of the vote away from the Republican candidate, making it an even closer contest. Last election year, the ORVS was perfect – in all 50% +1 ORVS districts, Republicans won.

regional **BREAKDOWN**

Below is a regional breakdown of House races that are hotly contested as well as the only two State Senate races in majority Republican districts with a Democratic Party opponent.

IN THE HOUSE

ABC-TEXO CHAPTER

HD 107 - 52.5% ORVS:

Incumbent Kenneth Sheets (R-Dallas) will face Democrat Victoria Neave (Dallas), in what could be this year's most competitive general election in the Texas Legislature.

HD 105 - 53.6% ORVS:

Another close race will pit incumbent Rodney Anderson (R-Grand Prairie) against attorney and Democrat, Terry Meza (Arlington).

HD 113 - 53.7% ORVS:

Democrat Rhetta Andrews Bowers (Rowlett) will test incumbent Cindy Burkett (R-Sunnyvale) for a seat in the House.

HD 102 - 54.4% ORVS:

Incumbent Linda Koop (R-Dallas) goes up against Democrat Laura Irvin (Dallas).

HD 114 - 56.3% ORVS:

Democrat James "Jim" Burke (Dallas) and Libertarian Anthony Holan (Dallas) will challenge incumbent Jason Villalba (R-Dallas) in November.

HD 112 - 56.8% ORVS:

House District 112 features incumbent Angie Chen Button (R-Garland) versus former Navy serviceman and Democrat Jack Blackshear (Garland).

HD 115 - 56.8% ORVS:

Incumbent Matt Rinaldi (R-Irving) will have to fend off Stanford educated lawyer and Democrat Dorotha Ocker (Carrollton) to keep his seat in the House.

ABC-GREATER HOUSTON CHAPTER

HD 144 - 49.3% ORVS:

Former Democratic State Rep. Mary Ann Perez (Houston) will challenge Gilbert Peña (R-Pasadena) for a chance to reclaim the seat she lost to Rep. Peña in 2014 by less than 1% of the vote.

HD 23 - 53.9% ORVS:

Former Democratic State Rep. Lloyd Criss (La Marque) contests incumbent Wayne Faircloth (R-Galveston) for HD 23. While Criss last served in the House in 1991, his legislative tenure spans over a decade, from 1979 to 1991. Criss has a history as one of the most pro-union legislators in the past 30 years.

HD 134 - 56.3% ORVS:

Another Houston race to watch will pit incumbent Sarah Davis (R-Houston) against Democrat Ben Rose (Houston) and Libertarian Gilberto Velasquez, Jr. (Houston).

ABC-CENTRAL TEXAS CHAPTER

HD 47 - 56.4% ORVS:

Businessman and incumbent Paul Workman (R-Austin) will face Democrat Ann "Ana" Marie Jordan (Austin) and Libertarian Scott McKinlay (Austin) in November.

HD 136 - 53.4% ORVS:

Incumbent Tony Dale (R-Cedar Park) goes up against financial planner and Democrat Paul R. Gordon (Austin).

ABC-SOUTH TEXAS CHAPTER

HD 118 - 44.2% ORVS:

In San Antonio, an interesting race to watch is HD 118, where Joe Farias (D-San Antonio) resigned mid-term in August 2015. That vacancy spurred a special election where Republican John Lujan (R-San Antonio) defeated Democrat Tomas Uresti (San Antonio) in a January special election runoff. This November, Lujan and Uresti will race again to decide who will serve HD 118 for a full two-year term.

HD 117 - 49.3% ORVS:

Incumbent Rick Galindo (R-San Antonio) faces former Democratic State Rep. Philip Cortez (San Antonio). An active Air Force serviceman, Cortez looks to reclaim his old House seat after losing it in 2014.

ABC-TEXAS COASTAL BEND CHAPTER

HD 43 - 52.5% ORVS:

In Corpus Christi, incumbent J.M. Lozano (R-Kingsville) will face fitness instructor and Democrat Marisa Garcia-Utley (Alice) in November.

IN THE SENATE

ABC-TEXO CHAPTER

SD 22 - 68.5% ORVS:

Democrat Michael Collins (Granbury) will challenge incumbent Brian Birdwell (R-Granbury). While no Senate race is within the 50%-56% hotly contested ORVS range, it will be interesting to see how an organized grassroots effort from Democrat Michael Collins will play out on election day.

ABC-CENTRAL TEXAS CHAPTER

SD 24 - 71.6% ORVS:

Senate District 24 is a race to watch as it is the only Senate race that will not feature an incumbent. With an ORVS of 71.6%, however, SD 24 is considered safely Republican. Republican Dr. Dawn Buckingham (Austin) will look to cruise past Democrat Virginia "Jennie Lou" Leeder (Llano) this fall.

A successful Texas businessman, Parker spent his childhood growing up in the North Texas region and attended college at the University of Dallas. After marrying his wife Beth over 22 years ago, they moved to Denton County where they proudly raise their two daughters, Lauren and Ashley. Parker is a lifelong conservative and began his career in public service as a White House intern under President George H.W. He was elected to the Texas Legislature in 2006 and continues to proudly serve today.

During the 84th Legislative Session, Parker was unanimously elected by his House colleagues to serve as the Chairman of the House Republican Caucus, responsible for leading and serving the overwhelming Republican majority. He was also appointed Chairman of the House Committee on Investments and Financial Services and is a member of the Ways and Means, Redistricting, and State and Federal Power and Responsibility committees.

Please describe your business background.

I currently own a consulting firm that specializes in assisting companies to improve their sales and marketing effectiveness. A majority of my current focus is in private equity and investments in biotech, agriculture, and retail pharmacy industries.

After graduating from the University of Dallas and the London School of Economics, I began my career in the securities industry starting with Dean Witter Reynolds in 1995.

Later, I joined Computer Sciences Corporation's Financial Services Group and worked in numerous positions in consulting, marketing strategy, M&A and eventually served as a Regional Vice President.

What is your view of the free enterprise system?

The free enterprise system is the heart of America's economic engine. As lawmakers, we should be in the role of minimizing regulatory burdens, creating a low and fair tax structure, and allowing the private sector to grow jobs and invest in our workforce.

Regulation should only be put in place when absolutely necessary and it must be predictable. Capital formation will not occur without businesses understanding the rules for engagement. Therefore, maintaining a predictable regulatory environment is essential to the future of the Texas economy and free enterprise itself.

The free enterprise system is run by the people of this nation, it is not a government construct. One either believes in the free enterprise system or in socialism. It's the choice between a free people making decisions for themselves and accepting the responsibility that comes with it or it's a government controlled system that interferes in every aspect of our lives.

It's one of the two, frankly, I don't believe there is anything inbetween. No economic system has done more to pull people out of the cycle of poverty and improve the human condition.

You co-authored our Neutrality in State Government Contracting bill in 2013 and authored it in 2015. Do you think we have a better chance of passage in 2017? If so, why?

Yes, I believe the Associated Builders and Contractors of Texas will be successful in the next session. With all the major issues facing the state in 2015 and only 140 days to complete those tasks, time got away from the Legislature. It gained a lot of momentum during the 84th Session, and I believe this increased visibility and awareness on the issue will carry it to passage in 2017.

What do you see as the biggest challenges facing the state this upcoming session?

Budgetary challenges will be a major issue coming into the 85th Legislative Session. While our Texas economy has remained strong, we are clearly being affected from the impact that significantly reduced oil prices are having on our state treasury.

In light of budgetary challenges, preserving funding for public education and our infrastructure investments, including transportation, will be some of the major subjects that require our attention. Additionally, Texas must take immediate action to restructure our Child Protective Services system in order to provide for the safety of the children placed in our care and the opportunity for these children to ultimately live a normal life.

What are your personal priorities this upcoming session?

As the Chairman of the Republican Caucus in the Texas House of Representatives, it is my priority to ensure that we have a strong, conservative session in order to keep Texas economically vibrant and to maintain our liberty and way of life.

Is there anything else you want to share with our membership?

I am very appreciative of the ABC of Texas organization for your commitment to strong free market principles and keeping the Texas economy robust. I look forward to working with your leadership and members during the upcoming legislative session.

Lien Law Modernization Proposal BY WES JOHNSON

s most of you already know, a Lien Law Modernization Proposal appeared and legislation will likely be introduced in the next Texas legislature. Associated Builders and Contractors of Texas and the Texas Construction Association presented a webinar on the specifics of the legislation.

I wanted to provide some insight as to the spirit of this legislation (i.e., how and why it appeared from the ethos).

In 2012, the Committee on Business & Industry of the Eighty-Second Legislature was, among other responsibilities, tasked with reviewing existing lien laws in Texas and making recommendations for improvement. As a result of those hearings, the Committee determined Chapter 53 of the Texas Property Code regarding Mechanic's, Contractor's, or Materialman's liens was a confusing patchwork lacking the continuity needed for a well-coordinated statutory scheme. In summary, the Committee tasked the construction industry with crafting a new scheme which would:

- simplify the process;
- provide owners with a means to prevent unwanted mechanic's liens of subcontractors and suppliers; and
- still allows all segments of the industry to protect their interests.

with its customer, the general contractor.

The need for a good working relationship many times outweighs a need or desire to engage in dispute or file a claim, potentially resulting in devastating financial consequences to subcontractors and suppliers.

The Committee determined that:

- Lien claimants should not be forced to make a choice between foregoing lien rights and creating a bad relationship with its customer.
- There should be a new lien law scheme that does not require lien claimants to make the choice.
- The existing lien laws are confusing and complex.
- A new scheme should be developed that is easier to understand and follow.

Overall, the Committee acknowledged that Chapter 53 was logical in concept, but further stated that numerous amendments over the years, many the result of the efforts of special interest groups seeking coverage of the statute for very narrow and specific interests, had resulted in antiquated provisions.

EVERYTHING BEFORE IT APPEARED HAD FIRST IT'S BEING IN SPIRIT - PLATO

The basis of the Committee's findings was a hearing in August of 2012 wherein the committee heard testimony regarding Texas Property Code, Chapter 53, dealing with Mechanic's, Contractor's or Materialman's Lien. In December of 2012 the Committee issued its findings (paraphrased):

- Materials and work are completed in advance of payment (credit basis) between individuals who generally, but not always, have prior working relationships and the steps to perfect a lien may become detrimental to the subcontractor's future business with its customer general contractor.
- During construction, subcontractors are many times required to provide owner's notice of non-payment regardless of the actual circumstances and even if the money is not due, either by contract or informal agreement. The due date of the notice is governed solely by when the work was performed.
- The notices, even though money is not due, can indicate to an owner that the general contractor does not pay its bills on a timely basis, causing unnecessary tension and hard feelings between the owner and general contractor, as well as the subcontractor. A subcontractor must choose between forgoing its lien rights or creating a bad business relationship

To address the task of responding to the Committee Report, in early 2013, three construction industry groups, Associated Builders and Contractors of Texas, Associated General Contractors-Texas Building Branch, and the Texas Construction Association formed a Lien Law Working Group. The Group was mediated and also had several volunteers with knowledge and insights on residential construction and remodeling, the title insurance industry, lending, and owners.

After three years of work, the Group published a Final Draft providing a framework of possible changes to Chapter 53. The overall consensus was a change in lien methodology from a "debt notice" system to a "preliminary notice" system. Although there was a general consensus, there were still some "Open Issues" identified in the comments made a part of the Draft.

Texas Gulf Coast Chapter


As summer ends and back-to-school days approach, the month of August brings thoughts of education to mind, and ABC Texas Gulf Coast Chapter is no exception.

ABC Texas Gulf Coast is on the move this back-to-school season,


working hard to advance and defend the principles of the merit shop in the construction industry and to provide members and their employees with the opportunity to succeed.

A strong group of both experienced and first-term legislators should be elected in 2016, and will approach the 2017 session prioritizing limited government, shrewd reforms, and the right allocation of funds for the interesting years ahead.
